Major Initiatives : Green Fleet

In 2016, 2016 ZEV Action Plan was issued, which increased the ZEV percent of state fleet purchases of light duty fleet assets to 50 percent by 2025. Additionally, in 2016 the California Department of General Services issued statewide policy that mandate five percent annual increases to the ZEV purchasing thresholds, starting in fiscal year 2017-18.
